Our primary work is enabling youth to develop into self-sufficient and confident riders who have the skills and knowledge to use their bicycles for transportation without depending upon adults. We envision a future in which kids riding bikes to school and adults riding to work is viewed as normal, and all have access to bikes at an affordable price or cost. We provide programs that support bicycling as transportation, physical activity and socialization for all ages.

Cycle Academy programs enable youth to develop into self-sufficient and confident riders. In Austin, we produced 2 BikeStart clinics teaching 62 youth how to ride, in-person and virtual Bicycle Skills Challenges programs instructing 3920 students, 74 Bike Club classes with 1515 attendees, and 3 community events with 2217 riders. In San Antonio, we produced 2 BikeStart clinics teaching 21 youth how to ride, in-person Bicycle Skills Challenges programs instructing 1820 Students, 8 Bike Club classes with 165 attendees, and 7 community events with 233 riders. As part of Bike Month and Bike to School Day in Austin we distributed 85 bikes valued at approximately \$34,000 along with helmets. In San Antonio we distributed 50 helmets and 174 bike lights.

4b (Code:) (Expenses \$ 91,162 including grants of \$ 0) (Revenue \$ 0)

Golden Rollers programs engage older adults and provides an opportunity for adults ages 50 and older and/or with differing abilities to engage in bicycle and tricycle based recreation, exploration and transportation. In Austin, we led 177 Trike Clubs classes at 9 sites and engaged 191 unique participants which resulted in 899 encounters. In San Antonio, we led 25 Trike Clubs classes at 2 sites and engaged 30 unique participants resulting 211 encounters.

City Cyclist programs educate and motivate the general population by hosting local events and participating with local groups, community nonprofits and businesses that want to promote cycling safety. In Austin, we produced 5 Beginning City Cyclist clinics for 67 participants and 15 Community Rides and events with 399 participants. Additionally, Ghisallo produced Bike to Work Day in partnership with the City of Austin, coordinated 48 fueling stations, led 2 group bike rides, and involved approximately 3500 cyclists during the Bike to Work morning event and 600 at the end-of-day After Party. In San Antonio, we participated in Siclovía and hosted a fueling station during Bike to Work Day.
